### From the Dept. of the Scribe


This Bulletin is submitted to the NUWC Golf League Members in pursuant if 28 C.F.R. 600.8 (c) which states that "at the conclusion of the scribe's work, he…shall provide the NUWC Golf League Members a report explaining the prosecution or declination decisions the Scribe reached during his investigation into actions and efforts early in the 2019 NUWC Golf League Season.

In the first few weeks of the 2019 NGL season, League members interfered in fair match play in a sweeping and systematic fashion. Evidence of these operations began to surface in Week 2 of the 2019 season. First, Captains were found to maneuver players within their team that favored their own team and disparaged opponents. This included the use of sandbagger subs and setting up one on one matches that favored their team. The investigation also identified numerous links between league players and unknown and unverified substitutes that were perceived to benefit their own teams.

Below I describe the evidentiary considerations, underpinning statements about the results of my investigation and the Scribe's charging decisions, and then provide an overview of the report.

Team 5 has shot to the top of the standings due to unsavory and manipulative actions by their Captain and unlikely substitutes. They appear to be running away with the  $1^{\rm st}$  half. Tim Fratus, Bob Wind and management mafia substitutes systemically

Team 7 is close behind primarily due to improper and illegal actions by Ray Harnois. Over the last several weeks, Ray



Team 1 is barely staying alive as their A squad of Petit and Coffland (subs) could not match up with Team 5. Although there is evidence that Team 5 had something to do with arranging this match as clearly seen by

Team 2 is fairing no better than Team 1 despite a strong showing of 39 points. There is evidence that other Team 2 players conspired to

And finally, we come to Team 3 which has three league officers and whose Captain is the President of the League. They sit in last place. Although this investigation discovered that the President and team members have shown signs of willingly allowing other Captains and league members to engage in activities that they thought would eventually benefit Team 3, this report concludes that the President neither conspired or coordinated any activities with these other entities. In addition, it is obvious that the President and his fellow league officers on Team 3 were ignorant to think any of these other activities would benefit them. Therefore, the President is exonerated of any charges.

#### **Notes:**

Captains should e-mail the handicapper, Pete Michno, no later than 1100 Thursday to give their line-ups. However, I'm sure the handicapper would appreciate Captains providing the line-ups earlier if you have them set. 1100 on Thursday should be the exception, not the rule.

Captains should inform all retirees and non-NUWC members on their teams to use the website for all League information.

<u>Dues - Even though the dues are listed in the rules, they are repeated here as additional encouragement for you to pay on time!</u>

You must pay by this May 9 if you do not want to incur penalties!!

League dues for NUWC employees, contractors and NUWC retirees will be \$40/year, payment received before 9 May 2019. Payment increases to \$45.00 if received after 9 May 2019. Members are responsible for paying their own dues. Payments can be made to any League Official. Make checks payable to "NUWC Golf League". Cash will also be accepted. Deadline for payments is 9 May 2019. Please read the rules as there will be reduction in points penalties assessed to teams that have members who have not paid by this date. Additionally, members who do not pay by the date indicated are subject to removal as a member and will be placed on the Sub List. Their position on the Team roster will be filled by the next eligible individual on the Sub List based upon membership criteria (frequency of filling in as a sub and handicap with respect to division roster spot needing to be filled). Team Captains are encouraged to ensure all Team Members pay their dues in a timely manner.

The old rich guy says, "I lied about my age."


